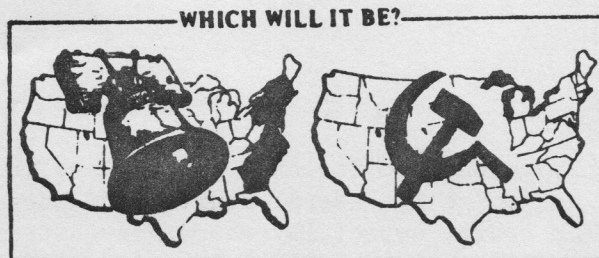

WHY A CITIZENS EMERGENCY DEFENSE SYSTEM?

1. THE NATION'S PROBLEMS: It is becoming increasingly obvious that the Federal Government is disregarding the Constitution of the United States in its actions. In recent years, it has all but destroyed the "spirit of American unity," by its illegal actions and policies. Among illegal acts it has committed are:

a. Allowing the illegal entry into the country of millions of aliens, most of whom know nothing about the Christian-American ethic and many of whom are trained enemy guerrillas and terrorists, who have been deliberately infiltrated for the purpose of disrupting American society and making American response to enemy aggression and terrorism less effective. Those who are not subversive consume a significant proportion of the resources earmarked for America's indigents; such resources, together with numerous services, are provided to illegal aliens despite the laws of the nation which prohibit such.

b. Favoring of ethnic minorities by the creation and implementation of illegal policies and programs, such as "affirmative action" hiring and promotion quotas, which are clearly unconstitutional, at the expense of productive citizens. All branches of the Federal Government, Legislative Executive, and Judicial, have been involved in these unconstitutional actions. In an earlier day many of our government leaders would have been "tried and executed for treason." Their action has caused a growing hatred between the favored minorities and the penalized majority. In short, the ethnic minorities have been made to feel sorry for themselves because of real or imagined wrongs to the point where they believe they should have privileges not given to others.

c. The betrayal of America by our national Legislature, as far as national defense is concerned. As a consequence the military power of the nation has deteriorated drastically and is inferior to that of the Soviet Union. We are now exposed to enemy encirclement and invasion by enemy forces supported by the Soviet Union, particularly from Mexico and Cuba. In addition to being often equipped with obsolete weaponry our military services have been further weakened by the government's imposition of arbitrary quotas relative to recruiting, job assignment, and promotion, often disregarding individual qualities. Under these circumstances it would be difficult for our military forces to repel a determined enemy attack anywhere. While we can handle a tiny, weak nation such as Grenada, we might not do so well against the Soviet Union.

d. Allowing enemy agents to infiltrate the Federal Government at all echelons. In 1982 the FBI stated that they knew of more than 100,000 enemy agents within the U.S., but that they could do nothing about this, other than to keep them under surveillance. A few years ago then Vice President Rockefeller headed an investigating committee to look into Communist infiltration of Congress. They came up with a list of over 800 such operatives. But when Senator Goldwater of Arizona asked for these to be named, Rockefeller was reported to have replied: "I can't give you this information since it would ruin detente." Such a situation makes it difficult, if not impossible, for the nation to counter hostile action by other countries - even if they were so disposed.

e. Ignoring the Constitution by intervening in legal actions by local governments to apprehend non-white criminals or to quell civil disturbances of an ethnic nature. Such intervention has instilled a pervading fear of federal government intervention for punitive purposes, making law en-

forcement a risky business when vigorous and forceful actions are indicated. Legislation by the National Legislature, judicial decisions by Federal courts, and bureaucratic edicts have had the effect of protecting criminals in court, especially where non-whites are concerned. Charges of "racism" are now being leveled by non-whites - with the encouragement of Federal agencies - at all levels of the justice system whenever minorities are accused of criminal acts. Law enforcement has become a farce in most areas, as the hands of the police have been tied by state and federal actions, and the criminal is protected to the detriment of the law-abiding citizen.

f. De-emphasizing of discipline in all aspects of life by governmental agencies and the discontinuation of teaching young Americans one of the most fundamental "laws of nature," specifically that individuals must bear the consequences of their actions. Instead, in the government school system our youth have been taught that they have no control over their destiny, but that their actions are brought about by environmental factors. The results can be readily seen: An almost unbelievable use of drugs and stimulants, a moronic disrespect for the property and right of others, a morality which rivals that of an "alley cat," and a complete disregard for their personal well-being, as well as that of others. These retrogressive steps taken by our government have created grave problems for society as a whole, notably in the schools, the courts, prisons, military service, and on our city streets. Respect for rules, regulations, and those in authority have suffered great damage, particularly in the attitudes and actions of the ethnic minorities.

g. Failing to respond in a positive and meaningful manner to threats made by various group leaders, to the effect that they will destroy white neighborhoods if their demands for "special treatment" are not met; the same "non-violence" advocated by the patron saint of violence, Martin Luther King, Jr. Such threats are being made openly in the media, with no action from the authorities.

2. ASSUMPTIONS. We can assume that in the foreseeable future, the following things will occur in this land:

a. Invasion of the United States by hostile military forces and by hordes of unfriendly civilians, probably coming while our armed forces are at war on foreign soil.

b. Internal rebellion by discontented ethnic minorities who have been taught that they have the right to expect anything they want. We can expect widespread riots, murder of whites, burning, looting, pillaging, rape and destruction in general by uncontrollable mobs in the "inner cities." Underground intelligence says that thirty large American cities are earmarked for destruction in this manner.

c. Major disruption of American business, industry, commerce, communications, and government itself by enemy agents in the nation, including guerrillas who have been sent into this country for that expressed purpose.

d. Economic disintegration throughout the nation, a collapse of the national currency, a halt of transportation systems across the country, non-operational utility systems in most places, hunger rampant, especially in the large cities, as the shelves of the supermarkets are rapidly emptied. Hospitals will be closed, robbery, murder, and rape will be common, business will be of the "black market" variety and people in the large cities will be hiding from maddened mobs.

e. Government at all levels will cease to function effectively, especially in areas with large ethnic minorities; and police will be unable to cope with the violence which will erupt everywhere.

3. DISCUSSION OF ACTIONS ESSENTIAL FOR SURVIVAL. People with foresight and a grain of common sense will see the possibility of the horrible things we have discussed and will not be led astray by the cries of "paranoia" which will be put out by the media and the liberal elements of our society. People who care will organize themselves for the protection of their families and friends and for their homes and personal possessions by the actions which will follow. Those who refuse to see the present danger will perish, many horribly!

a. There is no way that an individual, no matter how well armed or brave, can defend his family and home against a raging destructive mob. This is a fact which has been proven so often

throughout history that it merits no argument. To attempt it, or believe it is possible, is a certain road to doom.

b. Citizens of any community where such action takes place can expect no meaningful assistance from law enforcement agencies, either in the event of an enemy invasion, economic chaos, or civil anarchy fanned by the "white heat" of discontented minorities. Such agencies, including our military, will be rendered ineffective by "civil war" within their own ranks. Police officers will in many cases defect to protect their own families.

c. Members of a community MUST have some prior plan to protect themselves as a group. Such action MUST be initiated NOW. Once the need becomes clearly visible, it is too late. Neighborhood Defense Units MUST be organized; leaders must be selected and unit needs, such as arms, ammunition, food, clothing, shelter, safe places for the women, children and elderly, be provided NOW. Then unit defense plans must be put into effect and individuals trained as much as possible to react to any kind of an emergency that arises. The enemy knows the necessity of this kind of training, so they have already been taking measures to counteract any such training. In at least nine states in recent months laws have been passed against para-military training; in each instance they have been initiated by the Anti-Defamation League of the Jewish B'nai B'rith. In some areas where such laws have gone into effect, members of the Jewish Defense League (JDL) have been allowed to continue their training, even to the use of illegal automatic weapons. The laws seem to apply only to Christian defense organizations.

4. WHAT HAS BEEN DONE? The Christian-Patriots Defense League, recognizing the importance of this pressing problem several years ago, has organized the National Citizen's Emergency Defense System. As many of you know, we have advocated that our members work within the law and cooperate with law enforcement officials wherever possible. We have a large number of law officers in our ranks and have the assurance from many that, in a time of crisis, they will be with us. The same information has been given to us by officers in the National Guard. However, we must remember that the National Guard, in time of war, could well be outside the country. I personally believe that we should cultivate and cooperate with members of Civilian Defense units wherever possible. I believe that many of these would be on our side in case of an emergency.

a. Good leadership is essential and we believe that a Christian-oriented organization is a must, since without the help of God, we will be doomed. Not only should the leader be Christian-oriented, he MUST also be a patriot, where love for his country, his race, and his family come before any personal considerations. This is a Christian virtue, possessed by far too few of those who call themselves Christian. The Apostle Paul, writing in I Timothy 5:8, said: "But if any provide not for his own, and specially for those of his own house, he hath denied the faith, and is worse than an infidel." You can make your mind up to this. Paul was speaking of more than providing food, clothing, and shelter for them. He also had in mind their defense. Any man who has become so mellowed by the "sugar-coated pap" which has been preached in most churches that he refuses to take care of his own people is beneath contempt!

b. Our C.E.D.S. units operate on the principle of "leaderless resistance." This means that we do not follow a military format in organization. Each unit is a complete, "self-sustaining" unit—locally organized, led, equipped, and trained. Our Military Headquarters has no control over these units, other than in an advisory capacity and for liaison purposes. We do not want to know who belongs to a unit in an adjacent area; for in that manner, it is almost impossible for an infiltrator to destroy our entire organization.

c. C.E.D.S. units should establish contact with units in adjacent areas only through their command functions, and plans will be worked out to enable re-inforcement of units which may become hard-pressed by superior forces. If you have no such units in areas adjacent to yours, encourage the people to organize one.

d. The most serious problems, as far as civil anarchy is concerned, will occur in those areas having large ethnic minorities. Not all these minorities will take part in mob actions, and it could well be that many will be friendly and cooperative with us if we use some common sense in dealing with them. (After all, there were Mexican nationals who took part in the defense of the

Alamo.) Many people in the minority community will see that they will suffer most from unrestrained violence. We MUST not allow our people to sink to the level of unrestrained terrorist acts against these people. In spite of what we plan now, violence will explode if anarchy is sparked. This is a fact of life we must face. Along with violence, we always find brutality. It will not be missing from our ranks, no matter how much we would hope it would be. So we must run a well-disciplined organization. I would suggest that, while you are in the preparation stage, before trouble erupts, weed out from your organization those who refuse to accept orders and whom you will not be able to trust when the fighting breaks out. It will save you a lot of trouble if you take care of this unpleasant task now.

e. Every effort should be made for the military and civilian branches of the C.E.D.S. to cooperate to the fullest extent. This is the only chance we have for success. The military will be responsible for the safety of areas where our people locate for refuge; in some cases they will be called upon to escort our people to these areas. It will be the task of the Civilian Coordinator to provide some sort of shelter, food, and at least a minimum of medical attention. When I look at this stupendous problem, I believe that we who will do the fighting have the easier task.


f. If you are planning on an intermediate holding area for your people, prior to moving them to a more central safe area, I would suggest that you make some plans for defense of that area. This could consist of building watch towers, constructing barrier-type fortifications, and clearing the area for defense fire lanes. If it is not feasible to build defenses, then you must develop an intensive reconnaissance operation, especially when your neighborhood faces the threat of violence, to avoid a surprise attack of any kind from any direction.

5. THE IMPORTANCE OF THE ORGANIZATION. Remember, the sole objective of the C.E.D.S., singly and collectively, is to protect the lives and possessions of families in our immediate area from any attempt by an external group of any kind who tries to invade our area. This may mean fighting against your own kind; for almost invariably, in a situation such as this, bands of thugs, made up from the dregs of society, will be out in force to get whatever they can from either side.

One of the problems we will experience is the bitter hatred of some towards minorities, and groups such as the Jews. This can adversely affect unit effectiveness. Hatred must be subordinated to the main issue of defense. Our CEDS creed could well be summed up in these words: "We hate no one, but we will defend ourselves and our possessions against any attempt to destroy us!!!" A secondary creed could well be: "It is far better to be prepared for trouble and not have than to be destroyed from lack of preparation!" It's sort of like having a fire extinguisher in your home. You don't buy it because you expect the "joint" to burn down; but it's sure nice to have if it ever catches on fire.
